1. YOUR STORAGE FEE INCLUDING TAX IS \$ _____ PER MONTH AND IS SUBJECT TO CHANGE UPON NOTIFICATION OF SUCH CHANGE BY MAIL.
2. **TENANT GIVES BNRV/COSRV PERMISSION TO MOVE THE STORED *RV WHENEVER PRACTICABLE FOR OPERATIONAL EFFICIENCY OR FOR SAFETY REASONS OR EMERGENCY, THEREFORE, NO LOCKS ALLOWED ON UNIT HITCH / TONGUE.**
3. **BNRV/COSRV WILL NOT SEND OUT MONTHLY STATEMENTS. PAYMENTS WILL BE AUTOMATICALLY APPLIED ON THE FIRST OF EACH MONTH TO YOUR ENCRYPTED VISA OR MASTERCARD KEPT ON FILE. YOU WILL BE EMAILED A RECEIPT EACH MONTH.**
4. **BNRV/COSRV HAS THE RIGHT TO CHARGE YOU \$5.00 PER DAY ADDITIONAL TO YOUR STORAGE FEE FOR ANY CREDIT CARD DECLINED / PAYMENT NOT RECEIVED BY THE FIRST OF EACH MONTH. TENANT WILL ALSO BE RESPONSIBLE FOR LEGAL FEES, COURT COSTS, TOWING FEES AND ANY NECESSARY LEGAL ACTION CAUSED BY YOUR FAILURE TO MAKE TIMELY PAYMENTS.**
5. BNRV/COSRV RESERVES THE RIGHT TO DELIVER TO YOUR HOME ANY *RV THAT HAS A PAST DUE BALANCE, AT A HAULING FEE THAT YOU ARE RESPONSIBLE FOR OF \$300.00 UP TO 25 MILES AND AN ADDITIONAL \$3.00 PER MILE THEREAFTER, ROUND TRIP, IN ADDITION TO ANY STORAGE FEES ALREADY DUE AND OWING.
6. TENANT SHALL BE RESPONSIBLE FOR ALL COSTS ASSOCIATED WITH A BREACH OF THIS AGREEMENT INCLUDING ALL STORAGE AND TOWING FEES, LEGAL FEES AND COURT COSTS ASSOCIATED WITH THE COLLECTION OF ANY DEBT.
7. TENANT AGREES TO INSURE *RV ADEQUATELY FOR FIRE, THEFT AND / OR ANY OTHER PHYSICAL DAMAGE COVERAGE AT TENANT'S EXPENSE.
8. BNRV/COSRV IS NOT RESPONSIBLE FOR ANY PHYSICAL DAMAGE, VANDALISM, OR THEFT TO OR OF THE *RV, NOR FOR ANY THEFT OR LOSS OF ANY ARTICLES LEFT IN THE *RV.
9. TENANT AGREES TO GIVE BNRV/COSRV AT LEAST 48 HOURS NOTICE PRIOR TO REMOVING *RV FROM BNRV.
10. TENANT AGREES TO **HOLD** BNRV, CERTIFIED ON-SITE RV SERVICE, LLC. (COSRV) AND AFFILIATES **HARMLESS** FOR ANY AND ALL CLAIMS RELATED TO THE STORAGE OF THIS *RV.
11. **SHOULD YOUR *RV BE LEFT IN STORAGE ONE OR MORE DAYS PAST THE FIRST OF ANY MONTH, TENANT WILL BE RESPONSIBLE FOR AN ADDITIONAL MONTH'S STORAGE.**
12. ANY FUEL, OIL, GAS, ANTIFREEZE OR OTHER SPILLAGE WILL BE CLEANED UP BY TENANT AT TENANT'S EXPENSE.
13. BNRV/COSRV RESERVES THE RIGHT TO FORBID THE REMOVAL OF ANY *RV WITH AN UNPAID BALANCE.
14. **TO AVOID ADDITIONAL CHARGES, TENANT AGREES TO CONTACT BNRV IN WRITING WHEN TERMINATING THIS CONTRACT.**
